Participation numbers have been pretty steady for several years but towards the end of this year I have noticed a slight increase in numbers. The Tuesday night juniors have had to go to 2 sessions to meet demand and we have had over 40 kids turning up. The Tuesday and Friday morning social sessions normally have all tables in use and we could probably attract more people to these sessions if we had more tables. Sunday mornings have had some busy weeks and we may see this improve further now that we have 2 coaches using this session for some private coaching. It has even been a struggle to get on a table on a Monday night. The Spring Competition has attracted more players than the previous 2 seasons and hopefully we continue to see competition numbers grow next year.

One of the greatest assets we have is our wonderful group of volunteers. We would struggle to run the club efficiently without them and I would like to thank them for the contribution they make to the club.

Although the club is in a great position and going well, we are still struggling to attract people to join the executive committee. This is fine at the moment as things are going smoothly but there will come a time when new people are needed to take on some of the administrative duties. If anyone is at all interested in joining the executive committee now would be a good time to consider giving it a go.

Southern Table Tennis continued to have an active presence in the junior development space during the 2023 / 2024 reporting period. While the Tuesday Night Junior Program grew in size, Southern had school visits to the stadium. As part of the Sporting Schools initiative, Southern continued to deliver programs in the school environment exposing hundreds of students to table tennis. On the home front, junior squad training was held weekly and 'one on one' coaching was provided to some juniors looking to take the next step. Let's have a look at 2023/2024 in more detail;

- Tuesday Night Junior program for the most part of the reporting period, there were 30+ juniors in attendance. Numbers necessitated creating a second session on Tuesday nights, with the younger students attending a 6pm session and the older juniors attending a 7.30 pm session. This proved a successful approach to enable more personal attention to those in attendance. Across the reporting period, a total of 68 junior participated in the program. Worthy of noting is that there were 19 students who used their Sports Voucher in returning to the program, with a substantial 31 using their Sports Voucher in joining the program, with each new junior receiving a polo top, bat, bat cover and 10 weeks of program.
- Junior Squad for the most part of 2023 / 2024, a small junior squad met on a weekly basis to undertake group training. These players also entered TTSA sanctioned tournaments and all participated in the Smash Hit program.
- Smash Hit of the 35 juniors who participated in the program, Southern had good representation. As in the past, the program was conducted across 12 sessions with 6 sessions conducted at the Southern venue.
- Sporting Schools in the latter part of 2023, Southern delivered 28 sessions at the Hackham East Primary School and 12 sessions at Flaxmill Primary. Overall, some 200+ students received 4 sessions of table tennis. A couple of these students have since joined the Tuesday Night Junior program. I thank both Denise and Suoyi in assisting to deliver the sessions.

Additionally, although not a Sporting Schools activity, Southern attended the Sports Day of the Aldinga Payinthi College. Several sessions of coaching were delivered with some 150 students having a hit of table tennis.

- Stadium Hire it is always pleasing to have schools visit the stadium so Southern can showcase its venue. Southern Montessori Middle School, Hallett Cove East Primary, Morphett Vale East Primary and Christies Beach High hired Southern during the reporting period. Additionally, School Sport SA ran a schools round robin team event.
- Coaches it is pleasing that Callum Robertson obtained TOPS coaching accreditation, with both Jay Storken and Jose Navarro having just undertaken the course and in the throws of completing accreditation requirements. Southern will shortly have 7 accredited coaches available to help deliver the Tuesday Night Junior program and in some cases, undertake individual coaching.

Southern Table Tennis Junior Development Officer's Report 2024

- City of Onkaparinga Junior Tournament being the first TTSA sanctioned tournament of the year, this event attracted 44 registrations. Several Southern juniors participated in the tournament.
- DHS 'Working with Children' clearances I advise that all coaches, and potential new coaches all have a current DHS 'working with children' clearance.
- State Junior Team it was pleasing that both Callum Robertson and Jamie Hutchison were selected to represent South Australia at the National Junior Championships in Western Australia in July 2024.
- SA State Junior Championships TTSA selected Southern as the venue to host the 2024 SA State Junior Championships. The event attracted 46 registrations. It is always great to expose the greater table tennis community to the Southern venue.

While there is always more than can be done in the area of junior development, and that increased activity can be generated through social media, contact with schools in the area and other communication channels, having the human resource infrastructure is fundamental to lifting the junior development profile. That is a barrier yet to be conquered.

In closing, I thank all those coaches (Marcel Storken, Jo Storken, Suoyi Flierl, Callum Robertson, Jay Storken, Denise Tiller, Jose Navarro) and other persons who assisted me deliver the junior programs and activities in 2023/2024.
